

## Virtual **MAcc**

Do you or someone you know desire to get the MAcc? There has never been a better time than now.

State University now offers a virtual Master of Accounting degree. Students throughout the state of Utah, the country, and even the world can now join a live classroom in Logan, Utah from any remote location. What's more, these students are able to have the same interactive experience and engagement with other students and professors as if they were attending in-person.

The virtual Master of Accounting degree qualifies for a special program rate. This results in the cost of earning a Master of Accounting degree virtually at Utah State being just a few hundred dollars more than what Utah residents pay taking the same graduate accounting classes in-person on campus. The program can be completed virtually in 10-12 months or at a slower pace. This flexibility allows the program to fit within each student's individual needs and circumstances.

All 11 of our graduate accounting courses are taught twice in-person in a Logan classroom during the academic year. Now with : tively jumpstart your promising career.

e are pleased to announce that Utah ; the virtual Master of Accounting program, one of those two course offerings will include the option for students to enroll and attend virtually from any remote location. Like in-person students, students taking classes virtually are able to join the program during the fall, spring, or summer semesters and can take full advantage of program scholarship and recruiting opportunities.

> We remain fully committed to continue to serve our in-person students with the highest-quality instruction. While students are encouraged whenever possible to take classes in-person in Logan, students who normally attend in-person are welcome to take full advantage of attending classes virtually when they are out of town on internships or for other personal reasons.

> Whether you attend all of your classes in-person, virtually, or a combination of both delivery methods, you have the opportunity to earn the same Utah State University Master of Accounting degree that will continue to open up numerous opportunities and posi-

## Dual Accounting/Finance Degree

rofessor Devon Erickson currently chairs the curriculum committee for the School of Accountancy. After various conversations with undergraduate students who enjoyed their introductory accounting classes but shied away from pursuing an accounting degree due to their career interests, Erickson began brainstorming how to help all business students get better accounting training related to their varying degrees. Eventually, he met with faculty from the finance department and proposed the development of a dual degree path in accounting and finance. Under the reciprocal agreement, up to two accounting classes will count toward the finance undergraduate degree, and up to two finance classes will count toward the accounting undergraduate degree. Beginning in the fall 2023 semester, students with career interests in private equity, investment banking, real estate, personal financial planning, and other areas with emphases in both accounting and finance can follow proposed tracks with courses from both disciplines aimed at better preparing students for these career paths. As a result of the reciprocal agreement, students who wish to complete the dual degree program can do so by adding approximately one additional semester of classes to their plans of study.

"Our focus as a department and throughout the school of business is on doing what is best for the student," Erickson says. "By developing this dual-degree path, we believe the

School of Accountancy will maintain its high-quality undergraduate and MAcc paths for students interested in accounting-focused careers while enhancing the accounting and finance knowledge of students in other accounting-related careers. We believe accounting and finance students alike will benefit from enhanced cross-training in these disciplines."

Ultimately, Erickson hopes to develop similar paths at the intersection of accounting and other undergraduate degrees, such as data analytics and management, to help students in those areas develop adequate understanding of the language of business to prepare them for their careers.







## Meet the Firms

he School of Accountancy had its most successful Meet the Firms ever. It was held in the Perry Pavilion in Huntsman Hall on September 7. We welcomed a record number of firms to campus, including several new firms, along with many alumni and friends. We also had a record student turnout with nearly 175 professionally-dressed students. The energy level inside and outside the Perry Pavilion was high as students engaged in conversations with nearly 100 professionals from local and national accounting firms, industry companies, and government agencies. Meet the Firms is one of many recruiting events sponsored by the School of Accountancy each fall where students are able to network with professionals and gain insight into accounting careers.

For the first time ever, the School of Accountancy also hosted a Spring Recruiting night on January 26 for firms who were interviewing during spring semester. We intentionally made this a smaller event, only allowing a maximum of three professionals per firm. There was great support from both firms and students. ### AACSB Accreditation Reaffirmed

We are delighted to report that the School of Accountancy and the Huntsman School of Business have successfully completed our five-year continuous improvement process with the AACSB. The AACSB has reaffirmed our accreditation!

AACSB accreditation is the premier accreditation for business schools and accounting programs. It is known worldwide as the most recognized form of specialized accreditation that an institution and its business programs can earn. Accreditation is a voluntary, nongovernmental process that includes a rigorous external review of a school's mission, faculty qualifications, curricula, and ability to provide the highest-quality programs, with less than seven percent of accounting and business programs achieving this designation.

At the Huntsman School, the mission is to develop leaders of distinction in commerce and public affairs. Its purpose is to be a career accelerator for students and an engine of growth for the community, state, nation, and world.

Our peer review team recognized the quality and accomplishments of our program and were genuinely impressed with our students and the direction our program is moving. This accreditation process also represented an opportunity for us to learn from tremendous individuals with significant knowledge in academia. We look forward to continuing to improve in all aspects of our program.




Interning within the USBT group was a rewarding and memorable experience that enhanced my professional development. I'm grateful to the School of Accountancy for preparing me for such an opportunity.


Jacob added his thoughts as well:

Another with ties to the University of Georgia is Braiden Coleman, who is currently an Assistant Professor in Athens. A Cache Valley native who completed his doctoral studies at Indiana University, Dr. Coleman wrote, "My USU accounting professors are the primary reason I pursued a PhD! I am a first-generation student. When I started at USU, I honestly wasn't aware of many different career options (let alone in academia). Professors Doyle, Si-

His list of publications is long and impressive, including articles published in The Accounting Review, Contemporary Accounting Research, Journal of Accounting and Economics, Management Science, Review of Accounting Studies, and others. he Management Accounting Section Best Dissertation Award Committee selected SOA faculty, Dr. Grazia Xiong, as the winner of the 2023 MAS Best Dissertation Award for her dissertation, "How the Level of Firm Support for Employee Volunteering Affects Employee Productivity and Altruistic Behavior Inside the Firm."

The award is sponsored by the Institute of Management Accountants and includes a cash award and recognition plaques for both Grazia and her advisor, Dr. Drew Newman. Grazia is donating her cash award to the University of South Carolina Accounting Doctoral Program where she received her PhD.

Grazia joined USU in Fall 2022. During her one-year time at USU, she has already published articles at *Journal of Manage-ment Accounting Research* and *Issues in Accounting Education*. She has an active research portfolio including five working papers being submitted to top accounting journals. Her students call her "Dr. X" and are glad that she became a Utah State Aggie.

## PERFORM and EVALUATE

achel Martin researches various factors that influence performance evaluations and employee motivation. She recently co-authored a paper that was published in Accounting, Organizations and Society, a premier accounting journal, with Tyler Thomas (a faculty member at the University of Wisconsin-Madison). This paper examines how managers' knowledge of the performance evaluation process influences the way they set performance targets for employees. Performance targets are useful for employee motivation but can introduce risk to the employee if the target is not well-balanced; employees may be demotivated if targets are unrealistic, too difficult, or too easy. Many firms get around this problem by giving managers the ability to adjust compensation at the end of the performance period. In theory, this ex-post compensation discretion means that managers can ensure employees are properly rewarded and properly motivated, even if the targets were overly difficult or too easy in hindsight. The evidence provided in this paper highlights that this desire to protect and motivate employees on the back end



introduces them to more risk on the front end. Managers who know they will be able to adjust compensation at the end of the performance period set more difficult targets for their employees, spend less effort setting targets, and rely on the ability to make adjustments later rather than setting appropriate targets early. This tendency leads to a higher propensity to make compensation adjustments which can reduce the motivating effect of subsequent targets. Martin and Thomas' research highlights the need to understand the unintended consequences of evaluation and compensation policies.

### DR. W. STEVE ALBRECHT

Dr. Albrecht is a certified public accountant, internal auditor, and fraud examiner. He has enjoyed an inspiring academic career, including teaching at BYU, Stanford, and the University of Illinois. His career also includes service on many corporate boards, including SkyWest Airlines, Cypress Semiconductor, ICON Health & Fitness, and Bonneville International. He currently serves on the board of directors at the Larry H. Miller Company. His unique skillset and ability will help us refine and develop our approach to accounting education and an experiential learning environment.

Needless to say, we are thrilled to have Dr. Albrecht's experience and leadership to help guide us into the future. ■
